1. Introduction

Welcome to www.hitechinv.com ("HiTech Investments"). We highly value your privacy and are dedicated to safeguarding your personal information. This Privacy Policy governs your access to and use of this Website. By accessing or utilizing our Website, you agree to the terms outlined in this Privacy Policy.

2. Website Visitors

Similar to most website operators, we collect non-personally identifying information typically made available by web browsers and servers. This includes browser type, language preference, referring site, and the date and time of each visitor request. Periodically, we may release non-personally identifying information in aggregate form, such as publishing a report on Website usage trends or revealing viewing statistics on streaming videos.

We may also gather potentially personally-identifying information like Internet Protocol (IP) addresses.
